



# REGULATION

2020 EDITION

## I. Conditions

The Pool Design Awards contest is open to all qualified architects and pool designers worldwide. Only projects **completed after 2015 are eligible** (maximum 5 years of existence).

**Projects that have already been awarded prizes in the context of the FPP's Pool Awards or the EUSA Awards in 2019 are not eligible to take part in the 2020 Pool Design Awards.**

Candidates may be put forward on an individual basis or in groups, with no restriction regarding the number of team members. It's the actual projects that will be awarded prizes, not the individuals/teams.

The number of projects that may be presented by any single participant or team is unlimited.

Natural and biological pools are not eligible.

No registration fee will be charged for entering projects.

### **Deadlines:**

The contest starts on October 15<sup>th</sup>, 2019.

The submission deadline is June 15<sup>th</sup>, 2020.

The winners will be entitled to communicate on the results as of 1 October 2020.



## II. Categories

Prizes will be awarded in five categories:

- Pool Design Award – Sport and leisure pools
- Pool Design Award - Residential pools
- Pool Design Award - Renovated pools
- Pool Design Award - Small pools (< 10 m<sup>2</sup>)
- Pool Design Award – Wellness

Only the jury will define the category in which each project is entered.

## III. Application

Application must indicate the following information:

➤ **Project:**

- Name of project
- City and country of construction
- Year of construction
  
- General description of the project
- Photos of the project (number: min. 3 photos – high definition)
- Specific features of the project in terms of trends, design, client requirements and constraints.
- Technical description of the project: selection of materials, suppliers, choice of techniques used.
- Environmentally responsible dimension of the project, if any.
- Other information on the project and the companies who participated in it (builders, architects).

➤ **Builder:**

- Name of company
- City and country of the company
- Surname, first name and email address of the person in charge of the project

➤ **Architect:**

- Name of the architect's office
- City and country of the architect's office
- Surname, first name and email address of the person in charge of the project

The builder and the architect must inform each other of the submission of the application form for the Pool Design Awards contest and its results.

## IV. Jury

The international jury is made up of professionals from the pool and spa industry (architects and builders), journalists from the specialised and professional press, and representatives from the sector's professional federations. Only completed projects will be considered by the jury.

Following the jury's deliberations, all the contestants will be informed of the results by the organiser, GL events Exhibitions Operations.

## V. Prizes and awards

### ➤ *First prize winner in each category*

The representative of the winning project in each category will receive a VIP invitation to get to the Awards ceremony at the Piscine Global Europe 2020 exhibition taking place in Lyon (France) from 17 to 20 November 2020.

Travel expenses (i.e.: return transport tickets, accommodation, taxi, restaurant) will be reimbursed by the exhibition organiser, GL events Exhibitions Operations, up to a limit of €1500 including VAT, subject to production of original receipts.

They will benefit from the Pool Design communication resources:

- Presentation of the project in the dedicated area, the "Pool Design Gallery", at the Piscine Global Europe 2020 exhibition
- Presentation on the website of the Piscine Global Europe website, on the first page of the Pool Design Awards section, and on the Collection page
- Citation in a press release dedicated to the contest and sent to our entire network of contacts, in the build-up to the show
- Publication in the visitor documents for Piscine Global Europe 2020
- The project will be presented in the inspiration guide published on the occasion of the exhibition, and sent to the press, builders and architects, etc.
- Promotion on the social media pages of Piscine Global Europe
- Citation and presentation of the project in a news flash presenting the prize winners on the website of Piscine Global Europe

### ➤ *Second and third prize winners in each category*

The representatives of the second and third prize winners in each category will receive a VIP invitation to the Piscine Global Europe 2020 exhibition taking place in Lyon (France) from 17 to 20 November 2020

They will be invited to the Pool Design Awards ceremony. Travel or accommodation expenses will not be reimbursed by the organiser.

They will benefit from the Pool Design communication resources:

- Presentation of the project in the dedicated area, the "Pool Design Gallery", at the Piscine Global Europe 2020 exhibition
- Presentation on the website of the Piscine Global Europe website, on the Collection page

### ➤ *All other contestants*

All contestants who have submitted a project in the context of the Pool Design Awards will receive a code for free admission to Piscine Global Europe 2020 for them and their employees.

No travel or accommodation expenses will be reimbursed by the organiser.



## VI. Projects presentation and display

The award winners in each category of the Pool Design Awards will be presented in a dedicated area of the Piscine Global Europe 2020 professional exhibition (the Pool Design Gallery), along with the second and third prize winners in each category.

The design of this area and the information (texts, photos, etc.) displayed will be chosen by the organiser of the Piscine Global Europe 2020 exhibition, GL events Exhibitions Operations.

By submitting one or several applications, contestants agree to allow their projects and the information they provide, to be displayed on websites, social media and documents published by the organiser, and in the dedicated area in the Piscine Global Europe exhibition.

## VII. General conditions

All contestants expressly authorise GL events Exhibitions Operations to take photos of them during the contest, and to use any shots representing them, their pools and their projects, including the photos and text provided in the Application Form, their trademarks and logos (hereinafter referred to as the "Image"), whether provided by them or taken during the Piscine Global Europe exhibition. The contestants authorise GL events Exhibitions Operations to copy, edit, adapt and broadcast Images in whole or in part via any communication media and networks used in the context of the Piscine Global Europe exhibition including during the exhibition in a dedicated area, on the website, in the smartphone application and on social media dedicated to the Show, if applicable.

This authorisation is valid worldwide, from the day GL events Exhibitions Operations receives the Application Form for the Pool Design Awards from each Contestant and for a period of 6 years.

In this regard, the Contestants declare and warrant that they are the exclusive holders of the rights attached to the items referred to in their Application Form, including the Pool, the Photos and the Text and, therefore, that they have all the rights and authorisations necessary to give the consent granted herein to GL events Exhibitions Operations, failing which they are invited to give specific prior notice to GL events Exhibitions Operations or to hold it harmless from any claim that may be brought in connection with the use of the above-mentioned Image; In the event of any such claim, the Contestant concerned (1) authorises GL events Exhibitions Operations to withdraw any contested Image from any media dedicated to the exhibition and (2) undertakes to propose immediately a new Image to GL events Exhibitions Operations compliant with the above general conditions.

In accordance with French Personal Data Protection Act No. 78-17, Participants have the right to access, correct, rectify and delete data pertaining to them, which they may exercise by writing to GL events Exhibitions Operations.
